Quota places are allocated to NOCs.

C. ATHLETE ELIGIBILITY

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of IFAF, may participate in the LA28 Olympic Games.

Age requirements

- C.1.** All athletes must comply with the provisions of the [IFAF Eligibility Guidance](#) and be 18 years of age or older on 31 December 2028. Their [age](#) will be validated by the passport used for accreditation registration.

Additional IF requirements

- C.2.** To be able to compete in the qualification process, athletes must comply with the core eligibility requirements (age ranges, transgender policy and nationality) of IFAF.

The guaranteed quota place for both the men's and women's team is subject to their ongoing participation in the 2026 IFAF World Championships and the 2027 continental championships, and their ongoing compliance with the IFAF rules and regulations.
	D.2. 20 men (2 teams) 20 women (2 teams) <hr/> 40 (4 teams)	IFAF World Championships, Düsseldorf (GER), 13-16 August 2026 The IFAF World Championships will feature 16 men's teams and 16 women's teams. The two highest-placed eligible teams in the World Championships, for each gender, will obtain one quota place for their NOC for the LA28 Olympic Games.
	D.3. 30 men (3 teams) 30 women (3 teams) <hr/> 60 (6 teams)	Olympic Qualifier Series, location TBC, Q2 2028 (exact date TBC) The three highest-placed teams in the Olympic Qualifier Series, for each gender, will obtain one quota place for their NOC for the LA28 Olympic Games, representing a minimum of two continents. The Olympic Qualifier Series will be a 10-team tournament with the following quota of the best-ranked eligible teams from each 2027 IFAF continental championship: <ul style="list-style-type: none"> • two teams from the Americas Championship • two teams from the Africa Championship • two teams from the Asia Championship • two teams from the Oceania Championship • two teams from the European Championship Teams that have already obtained quota places for their NOC for the LA28 Olympic Games are not eligible to participate in the Olympic Qualifier Series. The Olympic Qualifier Series is a combined men's and women's tournament. If a national team declines entry, the next best-ranked national team from the continental championship will be invited.

E. CONFIRMATION

Confirmation of qualification places

- E.1.** IFAF will publish the results within three days of the event on its website: www.americanfootball.sport.

IFAF will confirm in writing to the NOCs the quota places they have obtained within three days of the last day of each event or ranking. The NOCs will then have two weeks to confirm to IFAF if they wish to use these quota places, as detailed in section H, “Qualification timeline”.

Confirmation of host country places

- E.2.** The host country must confirm the use of its host country places to IFAF in writing by 17 August 2026.

F. REALLOCATION

Reallocation of unused qualification places

- F.1.** If an allocated quota place is not confirmed by the NOC by the confirmation of quota places deadline or is declined by the NOC, the quota place will be reallocated as follows:

If the team qualified through the 2026 IFAF World Championships, the quota place will go to the next highest-ranked eligible team from the 2026 IFAF World Championships.

If the team qualified through the Olympic Qualifier Series, the quota place will go to the next highest-ranked eligible team from the Olympic Qualifier Series.

This is applicable for both women and men.

Reallocation of unused host country places

- F.2.** If the host country NOC does not wish to use its allocated quota place, this will be reallocated to the highest-ranked eligible team from the 2026 IFAF World Championships.

This is applicable for both women and men.
